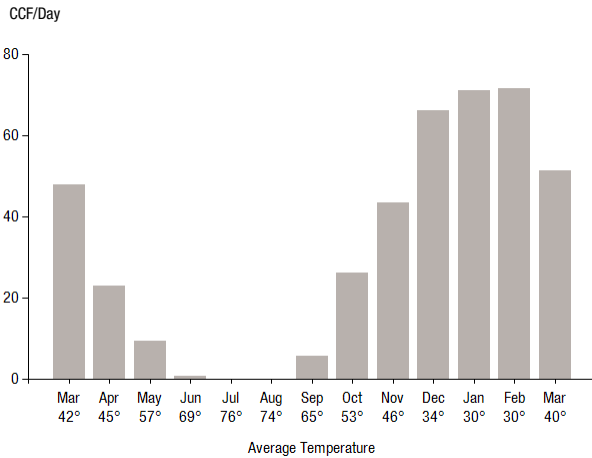

Gas Usage History - CCF



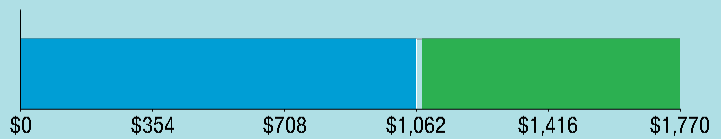
