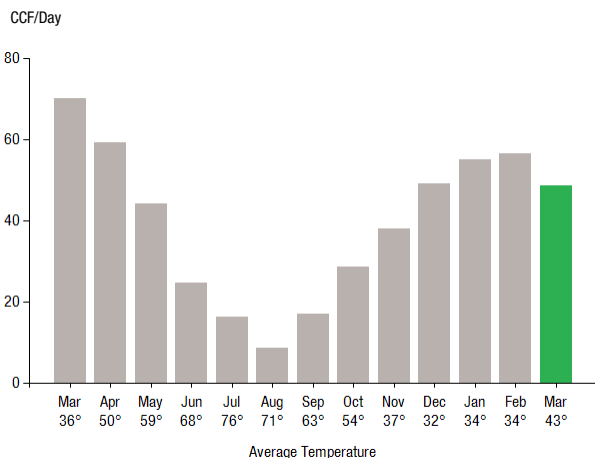

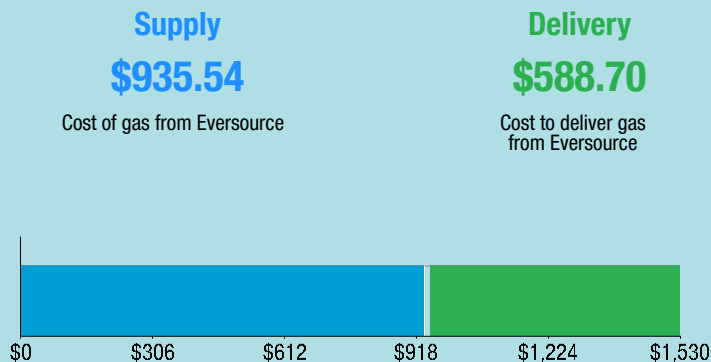

## Current Charges for Gas



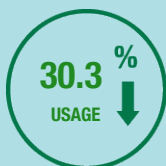
