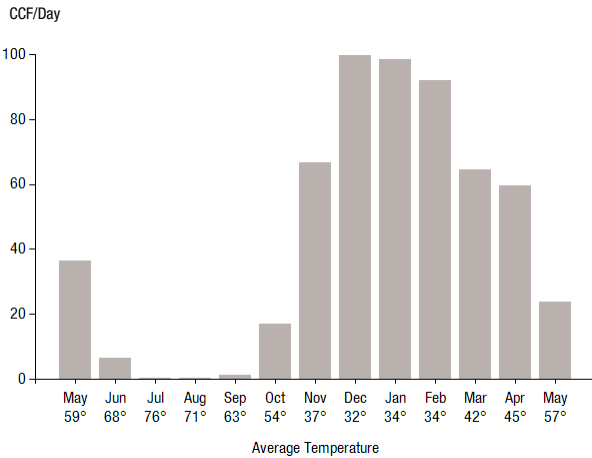

### Gas Usage History - CCF



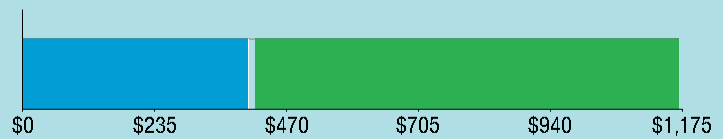

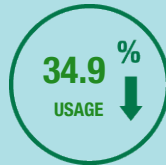
