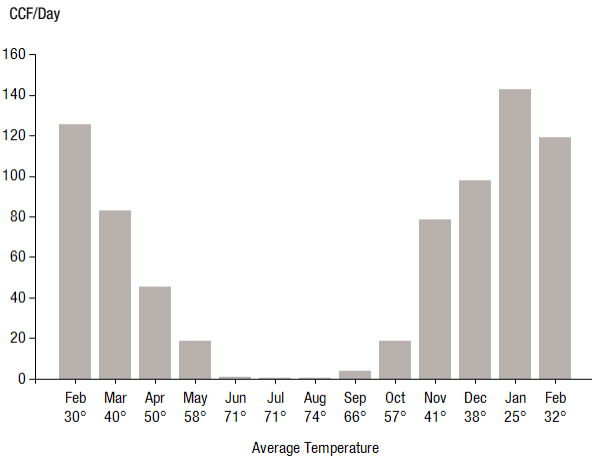

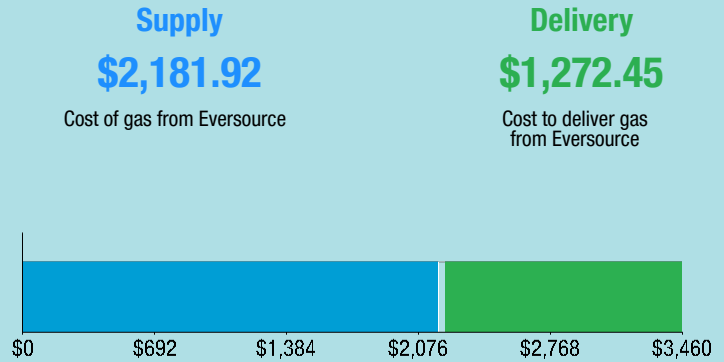

Current Charges for Gas



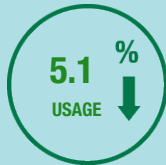
