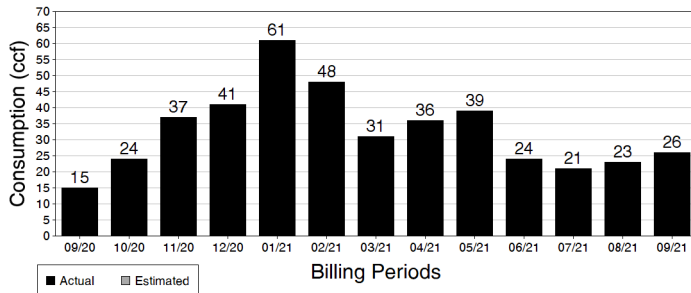

Enrollment and participation in a payment arrangement will prevent service disconnection and all customers are now eligible for a payment plan. If you are having trouble paying your bill, contact us as soon as possible so we can find a solution that best meets your needs.

We continue to offer flexible, extended payment plans – with no down payment – for any past due amount as well as a customer assistance program.

- Payment Plans:** Enroll in a COVID-19 payment plan to pay a past-due balance over a period of up to 24 months. As long as you make your payments, your service will not be disconnected for the duration of your plan. No down payment is required, and no fees or interest will be charged from the beginning of the pandemic through the end of your plan. The COVID-19 payment program is available to residential and commercial customers through September 30, 2021.
- Customer Assistance Program:** Customers who qualify can receive a one-time voucher ranging from \$50 to \$250 based on eligibility.

THE DPH FEE ENDED EFFECTIVE JULY 1, 2021: The DPH Safe Drinking Water Fee was an assessment rendered by the State of Connecticut Department of Public Health to support the department's ability to administer the Federal Safe Drinking Water Act.

WICA: Effective April 1, 2021, bills will contain a 9.78% Water Infrastructure and Conservation Adjustment (WICA) charge.

WRA: Effective April 1, 2021, bills will contain a -2.49% Water Revenue Adjustment (WRA) credit.
